NAME OF THE POST: Chief Forest Officer - 01 Post

LEVEL: Executive Director (E9 grade)

ELIGIBILITY: A serving Addl. Director General (State) / Jt. Secretary level (Central) – Level 14 of pay scale from Indian Forest Service.

Upper Age Limit: 55 Years

PERIOD OF DEPUTATION: Engagement will be for a tenure of 3 years extendable up to 5 years

BROAD JOB DESCRIPTION & RESPONSIBILITIES OF CHIEF FOREST OFFICER:

- The person so appointed should be well versed with extant Land Acquisition Acts and procedures i.e. The RFCTLARR ACT 2013, CBA ACT, LA Acts of various States, Right of Way and Right of User etc..., Panchayats (Extension to Scheduled Areas) Act, 1996 (PESA), The Indian Forest Act. 1927, The Wildlife (Protection) Act. 1972, The Forest (Conservation) Act. 1980, The Environment (Protection) Act. 1986, The Biological Diversity Act., 2002, Coastal Regulation Zone Act 2011 (CRZ), their amendments and related procedures for various clearances from appropriate authority.
- Assisting various projects, stations, coal mining sites, hydro projects and other group companies including JVs in preparing proposals for obtaining various clearances (Forest clearances, environment clearances, other clearances and ensuring compliances thereof).
- 3. Compliances of directives/guidelines issued by MoEF & CC on Forest/Environment matters from time to time.
- 4. Liaison with various Ministries including MoEF & CC, Regional offices of forest department, various Advisory Committees (such as Forest Advisory Committee, Expert Appraisal Committee etc), State Authorities for arranging of timely approvals from appropriate authority.
- 5. Oversee afforestation initiatives across various Regions and sites of NTPC Ltd and other group companies including JVs.
- 6. Any other related activity as deemed fit and necessary for business operations of the company.

GENERAL CONDITIONS:

- 1. Only Indian Nationals are eligible to apply.
- 2. All qualifications should be from Universities / Institutions recognized and approved in India.
- All computations of age/ experience requirement / qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
