TIBETAN SPIRITUAL leader the Dalai Lama Tuesday left for the US, where he will undergo a prostate surgery. The surgery will be done at Mayo Clinic in Rochester, Minnesota. The Dalai Lama has been advised rest for a month, till February-end.

The Dalai Lama, who turned 80 in July last year, was diagnosed with a prostate ailment nearly two years ago. He has received treatment for this in the past, too. His official website made the announcement Tuesday and said the Dalai Lama's "regular engagement schedule shall resume in March."

This means the Dalai Lama will not be present in Rewalsar, Mandi district, where Tibetans are planning a grand event on February 7 — the Tibetan New Year (Losar). It was inaugurated by the Dalai Lama.

AUSU president invites journalist to campus, ABVP on hunger strike

LALMANI VERMA LUCKNOW, JANUARY 19

THE TUSSLE between Allahabad University Students' Union (AUSU) president Richa Singh and RSS's student wing ABVP led to fresh trouble on the varsity campus over a national seminar being organised by Richa, for which she has invited journalist Siddharth Varadarajan as chief speaker.

The ABVP leaders, who hold other significant posts in the union, sat on indefinite hunger strike on Tuesday outside the residence of university Vice-Chancellor R L Hangloo, demanding cancellation of the seminar. The seminar, on 'Democracy, media and freedom of expression', will be organised on Wednesday and presided over by Hangloo.

AUSU vice-president Vikrant Singh said, "There are two reasons behind our protest. First, the union president did not consult us before planning the event. Secondly, Siddharth Varadarajan is a controversial man... Richa has invited a person who has a communal mindset, while she had opposed the campus visit of BJP MP Yogi Adityanath last year, calling him communal."

Dismissing the protests, Richa said Varadarajan is an unbiased journalist and ABVP leaders should read his articles before making derogatory remarks about him. She added that ABVP

leaders were opposing the seminar only to settle scores over the November incident, when she had opposed Yogi Adityanath's visit.

The union president said she did not discuss preparations of the event with other union members because they too hold several events on campus without consulting her.

Richa further claimed she was being targeted by ABVP members of the union for being a woman and the university administration was also under their pressure. "ABVP members are targeting me because they can't tolerate a woman as president. A woman got elected in AUSU after 128 years and they want to create an atmosphere where no woman can dare contest elections in future," she alleged.

Dr N K Shukla, university proctor, said, "We are keeping a watch on the situation. No decision has been taken on their demands so far."

Later in the day, Richa wrote to the President, the PM and the HRD Minister on the issue.

SC allows open court hearing for death-row convict Mohd Arif

Curative petition already rejected, SC makes exception

EMPHASISING ON the irreversibility of death sentence, the Supreme Court Tuesday granted 2000 Red Fort attack convict Mohd Arif an open court hearing to convince the court why his punishment required reconsid-

Giving hope to the death row convict, a Constitution Bench led by Chief Justice T S Thakur said Arif's review petition shall be heard in open court again if he files such a plea within a month.

Arif, the court held, shall get this opportunity irrespective of the fact that his curative petition has already been dismissed. The bench modified a previous order that had disentitled death row convicts to seek open court hearings of their review petitions if their curative petitions had been rejected.

By a verdict in September 2014, the court had ruled that all review petitions of death row convicts shall be heard in an The victims were reportedly open court by a three-judge bench. But the convicts whose curative petitions had been dismissed before this judgment were deprived of this benefit. Earlier, review petitions were heard in judges' chambers. However, on Tuesday, the

Bench underscored that it was the irreversible nature of capital punishment that had prompted it to allow open court hearings in such cases and convicts should not be denied this opportunity only because their curative petitions had been dismissed. It also observed that since

very limited grounds are available to a convict in a curative petition, whereas he can argue on various points in the review petition, dismissal of a curative petition may not be held as the final word on the facts of the case.

It asked Arif's counsel to file a fresh review petition within a month and then the matter shall be placed before a three-judge

The apex court on April 28, 2014 had stayed Arif's execution. Three people, including two Army personnel, were killed in the December 22, 2000 Red Fort attack. On August 10, 2011, the Supreme Court upheld Arif's death sentence and dismissed his appeal challenging the capital punishment awarded to him by a sessions court, which had been affirmed by the Delhi High Court.






